Internal regulations of Lake Barterand

Barterand Lake is a 2nd category lake, in the public domain, property of "fishing federation of Ain", rented to the AAPPMA of Bas Bugey, by lease received by Mr. Paul CHASTEL, then notary in Belley, on December 1st 1954, for 90 years from June 1, 1955, modified by agreement notarized in the minutes of Mrs. BEAUDOT, notary in Bourg en Bresse. All people coming to fish at Lake of Barterand undertake to respect the following regulations:

Article 1

The lake called "Lac de Barterand" is reserved for angling.

Article 2

The lake and its facilities (port and pontoons) are reserved for members of the AAPPMA du Bas Bugey, holders of an AAPPMA fishing card with reciprocity as well as holders of a daily fishing card.

Article 3

The house of fishermen and its enclosure are reserved for administrators and members of the AAPPMA du Bas Bugey.

Article 4

The use of the enclosure known as "Barterand beach" is exclusively reserved for fishermen (see article 2) and fishing activities. Therefore, swimming and water activities are prohibited in and on the lake. During the surveillance period, the use of the enclosure known as "Barterand beach" is strictly reserved for swimming.

Article 5

Angling with a boat or other floating device is authorized after paying a boat stamp (available on the cartedepeche.fr website).

Article 6

The price of the boat stamp is set at € 25/year and per fisherman. The stamp is available on the cartedepeche.fr website as well as at associated dealers. Children under 18 accompanied by an adult with their boat stamp will be able to fish without it.

Article 7

The following are prohibited on the lake:

- Sailing boats of all types
- Boats for sports use (rowing, canoeing, kayaking, paddle)
- Beach gear, rafts, windsurfing, etc.
- Scuba diving

This list is not exhaustive, only boats containing emergency services, police, daycare, maintenance managers and veterinary managers are exempt from these prohibitions.

Article 8

All boats, in accordance with current national rules, must have as many life jackets as there are occupants.

Article 10

All boat owners who do not have a mooring ring at the port of Lake Barterand must get out of the water and evacuate their boat at the end of each fishing trip.

Article 11

The rent of mooring rings to the port of Lake Barterand is subject to the payment of an annual fee as a contribution to the port's maintenance costs. The fee must be paid when requesting the ring. Payment of the fee for the year results in the reservation of the ring for the following year unless a cancellation request is made to the AAPPMA before December 31.

Article 12

The price of the fee is set at 37 euros and must be paid no later than January 31 of the current year.

Article 13

The fee is due for an entire year, regardless of the launching date and the length of time the ring is occupied. No relief will be granted in the event of a drop in the lake level, particularly during low water periods, even if these causes non-use of the facilities. Any subletting is prohibited.

Article 14

The owners of the boats must ensure their good condition and good flotation. The AAPPMA may provide the necessary equipment to help the owners (help to remove the boat, boat trailer, pumps to empty the boat...). A rental contract will formalize the commitment of fishermen with a ring at the port.

Article 15

In case of non-compliance with article 14, the owner will receive a first letter of information asking him to repair his boat, which will be followed by a second letter with acknowledgment of receipt if nothing is done. This second letter may provide for the removal of the boat by the AAPPMA and the place in the port will therefore be lost.

Article 16

The use of the electric motor is tolerated on Lake Barterand. The AAPPMA reserves the right to prohibit it at any time if its use becomes abusive and harmful to the practice of angling and the environment.

Article 17

The opening and closing dates, the quotas as well as the mesh sizes for fishing are regulated by the Fishing Regulations of the Ain department. This ARP is available on our website.

Article 18

Fishing in the outlet reach of the lake, from the entrance of the channel to the bottom grid of the channel, is exclusively and strictly reserved for children under 12 years old.

Article 19

Fishing distances are limited as follows:

- -prohibition of passing the fishing stations located on each side of the post.
- prohibition of going beyond half of the lake, whether in the direction of length or width.

Article 20

In order to allow good coexistence between fishermen, it is requested:

- to use markers to indicate your fishing location.
- to cast the banners of the lines.
- to respect a suitable distance between each fisherman so as not to cause discomfort.

Article 21

Also prohibited on the lake and its surroundings:

- washing vehicles.
- manipulation of lake level regulation structures without authorization.
- pollution of the lake, its banks and its surroundings.
- wild camping.
- campfire on the ground.

Article 22

The private guards of the AAPPMA du Bas Bugey are sworn on the AAPPMA fishing lots and particularly on the Lake of Barterand, they are authorized to enforce these regulations.

Article 23

tThe use of a removable shelter such as a tent, a bivvy or an umbrella shelter is equivalent to camping, including converted vehicles. Wild camping is prohibited. Only the use of "umbrella" type shelters without groundsheets will be tolerated.

Article 24

In case of non-compliance with the internal regulations, the private guards or administrators of the AAPPMA du Bas Bugey will take the necessary measures to enforce them.

Article 25

These internal regulations will be sent to all members of the AAPPMA du Bas Bugey and to holders of a place in the port. It will also be available on the AAPPMA website as well as displayed at the fishermen's house.
